Child Nutrition Policy Analyst for School Nutrition Programs

Position Available

The Food Research and Action Center (FRAC) seeks a talented and experienced anti-hunger and nutrition advocate to fill the position of Child Nutrition Policy Analyst working to expand and improve the School Breakfast and National School Lunch Programs. This position reports to the Director of School and Out-of-School Time Programs.

Working with FRAC's widespread network of national, state and local anti-hunger groups and its education, health, and youth development partners, the successful candidate will expand the use of the School Nutrition Programs among schools and low-income children, with a primary focus on the School Breakfast Program, and will seek ways to improve the programs' services and accessibility. The ultimate goal is to ensure that millions more children are receiving the food they need, that families obtain the support such programs provide, that school nutrition policies contribute as much as possible to children's wellness, and that the nutrition programs support low-income children's educational achievement and health. This position offers opportunities to work in coalition with FRAC's education partners and to gain experience as a program analyst, strategist, coalition builder and project manager.

Organizational Background

FRAC is the leading national nonprofit organization working to improve and implement effective public policies and public-private partnerships to eradicate hunger and undernutrition in the United States. FRAC engages in research, policy analysis and advocacy, coalition-building, outreach, technical assistance and training, and an array of communications strategies. FRAC works in partnership with hundreds of national, state and local nonprofit organizations, public agencies, corporations and labor organizations to address hunger and food insecurity, and poverty as their root cause. FRAC is conducting a search for a Policy Analyst to help lead FRAC's national, state, and locally-targeted efforts to expand and improve the School Breakfast and National School Lunch Programs.

Duties and Responsibilities

- Assess the reach and quality of the school nutrition programs (school lunch and school breakfast) in targeted states and districts, as well as in the nation as a whole.
- Provide appropriate information, technical assistance, analysis, training, strategic
 advice, and other hands-on support to national, state and community-based
 organizations, states, school districts, schools, and activists regarding ways to improve
 and expand use of the school nutrition programs, including implementation of strategies
 like Breakfast After the Bell, Community Eligibility, and improved nutrition standards.
- Assist in the growth of effective local, state, and regional coalitions that work on school nutrition issues.
- Work with school districts and local, state and federal government agencies to develop and implement expansion and policy improvements that increase access to the school nutrition programs.

- Evaluate the effects of existing or proposed legislation, regulations, policies and practices in order to determine ways to defend, improve and expand use of the school nutrition programs.
- Write persuasive analytic materials, guides, outreach materials, and reports for use by advocates, government agencies, policy makers, service providers, and the media.
- Manage data projects and analyze national and state participation data in the school nutrition programs.
- Make presentations to diverse audiences at local, state, regional and national conferences and meetings on expanding access to participation in, and quality in the School Breakfast and National School Lunch Programs.
- Represent FRAC at coalition and partner meetings.
- Speak to local and national media representatives about school nutrition program issues.

Skills and Experience

The ideal candidate will possess the following characteristics:

- Minimum 3 years of experience in advocacy, program oversight, policy analysis and/or organizing.
- An advanced degree in law, public policy or a comparable field or comparable experience.
- Experience in nonprofit, government or policy work strongly preferred.
- Ability to work independently and as a member of a team.
- Experience analyzing and interpreting data strongly preferred.
- Demonstrated ability to think and act strategically.
- Knowledge of the school nutrition programs and effective expansion strategies strongly preferred.
- Exceptional written and verbal communication skills.
- Strong interpersonal skills.
- Unquestioned integrity, a high level of energy, and a sense of humor.
- A commitment to social justice.
