

House and Senate Agriculture Appropriations Funding Levels for FY 2019

The agriculture appropriations bill is one of 12 appropriations (spending) bills that Congress must pass by September 30 of each fiscal year to keep government programs funded. The House Committee on Appropriations approved its Fiscal Year (FY) 2019 Agriculture Appropriations Bill on May 16, 2018, while the Senate Committee on Appropriations approved its FY 2019 Agriculture Appropriations Bill on May 24, 2018. Similarities and differences are outlined in the table below.
