The Associate provides programmatic and related support for FRAC's legislative advocacy efforts, field outreach, coalition building, policy conference planning and coordination, e-advocacy, messaging and communications with Capitol Hill offices and overall support for FRAC's government affairs priorities. Experience in social and digital media is a prerequisite. Leading candidates also will have a demonstrated ability to accurately grasp, articulate, and advance FRAC's mission and act effectively in collaboration with multiple stakeholders.
