

# THE WIC PROGRAM: Improving Maternal and Child Health and Food Security in NEBRASKA

The Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) provides pregnant, postpartum, and breastfeeding individuals, infants, and children up to 5 years of age from households with low incomes with nutritious foods, nutrition education and counseling, breastfeeding support, and referrals to health care and social services.

WIC provided essential nutrition and health support to **7,570** women; **8,442** infants; and **21,325** children.<sup>8</sup>

WIC spent **\$25,821,536** at food retailers; provided **\$10,787,150** in formula rebates; and provided **\$13,710,711** in nutrition education, breastfeeding, and administration funding.<sup>9</sup>
