

THE WIC PROGRAM: Improving Maternal and Child Health and Food Security in TENNESSEE

The Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) provides pregnant, postpartum, and breastfeeding individuals, infants, and children up to 5 years of age from households with low incomes with nutritious foods, nutrition education and counseling, breastfeeding support, and referrals to health care and social services.

ACTION IS NEEDED TO KEEP WIC STRONG AND TO CONNECT MORE ELIGIBLE PEOPLE TO THE PROGRAM.

WIC spent **\$119,971,479** at food retailers; provided **\$35,450,476** in formula rebates; and provided **\$46,303,786** in nutrition education, breastfeeding, and administration funding.⁹
