Position Available

The Food Research and Action Center (FRAC) is looking for a Legislative and Conference Coordinating Intern to support the work of the legislative department, in addition to supporting the program planning of the 2020 National Anti-Hunger Policy Conference. This internship will provide work experience in public policy development, advocacy, and events planning at a nonprofit organization. The ideal candidate will be available to start as soon as possible with availability through March 2020.

Organizational Background

FRAC is the leading national nonprofit organization working to improve and implement effective public policies and public-private partnerships to eradicate hunger and undernutrition in the United States. FRAC engages in research, policy analysis and advocacy, coalition-building, outreach, technical assistance and training, and an array of communications strategies. FRAC works in partnership with hundreds of national, state and local nonprofit organizations, public agencies, corporations and labor organizations to address hunger and food insecurity, and poverty as their root cause.

The intern's primary responsibilities include:

- Scheduling meetings on Capitol Hill.
- Scheduling and assisting in the planning of activities for FRAC's coalition meetings.
- Monitoring Capitol Hill briefings, hearings, and other events.
- Providing administrative support and coordination of conference workshop and program planning for the 2020 National Anti-Hunger Policy Conference (February 29 – March 3, 2020, held in Washington, DC). Duties could include assisting staff across departments in workshop development, coordinating and assisting in securing speakers for plenaries and workshop sessions, organizing lobby day visits and activities, and providing logistical support for all aspects of the conference.
- Providing general administrative support to the Legislative Unit.

Skills and Qualifications:

- Bachelor's degree or working towards one. Graduate students are encouraged to apply.
- Interest in anti-hunger policy and anti-poverty advocacy.

- Interest and/or experience in conference and events planning preferred. Events geared towards a national audience a plus.
- Impeccable organization skills with attention to detail and ability to prioritize and multi-task.
- Superb written and oral communication skills.
- Excellent MS Office skills, especially in Excel.
- Basic knowledge of federal public policy process a plus.

Requirements:

- Must be able to commit to at least 5 months (through March 2020).
- Minimum of 12-20 hours a week on a regular schedule for the Fall semester with increased hours from January-March.
