The 2022–2023 school year marked the return to normal operations for school food service departments across the country. Despite ongoing operational challenges, schools could no longer use the nationwide waivers that were widely available during the COVID-19 pandemic. Most impactful was the loss of the Seamless Summer Option (SSO) waiver, which allowed schools to offer meals to all students at no charge while receiving a higher reimbursement rate. As a result, most districts had to return to a tiered eligibility system that requires them to collect, process, and verify school meal applications, and millions of children lost access to free school meals

Offering school meals to all students at no charge supports parents and guardians, decreases child hunger, eliminates stigma, and streamlines food service operations. Concern over losing the opportunity to offer all students healthy school meals ignited action among states and school districts. Three states — California, Maine, and Vermont — enacted Healthy School Meals for All policies, and three states — Connecticut, Massachusetts, and Nevada — extended it through the 2022–2023 school year.¹ And nearly 7,000 more schools implemented the Community

Eligibility Provision (CEP), which allows high-need districts and schools to offer school breakfast and lunch at no charge to all students, bringing the total number of schools adopting community eligibility to 40,235.²

Despite efforts to sustain and expand students' access to school meals, districts continued to face a multitude of challenges that affected participation and program viability. Rising food costs, labor shortages, and supply chain disruptions, coupled with the return of charging for meals, have contributed to reports of declining participation in many school districts. Families have been confused about the change from pandemic operations; stigma surrounding school meal participation and school meal debt has returned; and schools are burdened with increased administrative work.

To ensure that children have access to healthy meals, and that districts have the support needed to operate robust programs, school meals must be available to all students at no charge. This report reveals that when school meals are offered free of charge, and when breakfast service is integrated into the school day, participation increases and children have access to the nutrition necessary for success.



Survey Sample

FRAC surveyed a select number of large school districts on their school meals participation and operations in April 2022 and October 2022, covering school years 2021–2022 and 2022–2023, respectively. For this report, a large school district was defined as having an enrollment greater than 7,000 students.


Ninety-one districts across 40 states and the District of Columbia completed an electronic survey between February and March 2023. District size ranged from 7,353 students in Inglewood Unified School District (California) to 996,959 students in the New York City Department of Education (New York).



KEY FINDINGS

- ▶ The 91 school districts highlighted in this report included a total of 10,748 schools representing 6,520,586 students.
- ▶ Average daily participation in breakfast decreased by 100,747 students across all surveyed districts — from 1.84 million children participating in breakfast each day in April 2022 to 1.74 million participating daily in October 2022.
- ▶ Average daily participation in lunch decreased by 250,738 students from 3.61 million students participating in lunch each day in April 2022 to 3.36 million participating daily in October 2022.
- Collectively, most school districts served fewer children both school breakfast and lunch in October 2022 compared to April 2022. Thirty-three districts saw an increase in breakfast participation from April 2022 to October 2022, and 28 districts saw an increase in lunch participation from April 2022 to October 2022.
- > The combined reach of breakfast among the 91 districts trailed lunch in both April 2022 and October 2022. In October 2022, only 56 students from households with low incomes participated in school breakfast for every 100 that participated in school lunch.

APRIL 2022

- In April 2022, 91 school districts (100 percent) offered school meals to all students at no charge through the SSO waiver. All the meals served were reimbursed at the free rate
- In April 2022, a total of 30,740,765 breakfasts were served over an average of 18 operating days in the 91 districts surveyed.
- In April 2022, a total of 60.223.706 lunches were served over an average of 18 operating days in the 91 districts surveyed.

OCTOBER 2022

- ▶ In October 2022, **7,576 schools** across 10.687 schools offered breakfast and lunch to all their students at no charge through utilization of the Community Eligibility Provision, Provision 2, states' Healthy School Meals for All policies, or local non-pricing initiatives.
 - » 33 school districts (36 percent) offered breakfast and lunch to all students at no charge at every school in the district
 - » 40 school districts (44 percent) offered breakfast and lunch to all students at no charge at some schools in the district

- » 18 school districts (20 percent) did not offer all students meals at no charge in any of their schools.
- In October 2022, a total of 33.207.623 breakfasts were served over an average of 19 operating days in the 91 districts surveyed.
- » 28.119.914 breakfasts (85 percent) were reimbursed at the free rate.
- » 685.862 breakfasts (2 percent) were reimbursed at the reduced-price rate.
- » 4,401,847 breakfasts (13 percent) were reimbursed at the **paid** rate.
- In October 2022, a total of 63.651.236 lunches were served over an average of 19 operating days in the 91 districts surveyed.
 - » 50.018.721 lunches (78 percent) were reimbursed at the **free** rate.
 - » 1.640.802 lunches (3 percent) were reimbursed at the reduced-price rate.
 - » 11.991.713 lunches (19 percent) were reimbursed at the **paid** rate.



Child Nutrition Programs and Nationwide Waivers

During the 2021–2022 school year, the U.S. Department of Agriculture (USDA) extended nationwide pandemic-related waivers that gave districts the flexibility needed to operate child nutrition programs during volatile circumstances, such as labor shortages, supply chain disruptions, and school closures. Every school district included in this report utilized at least one waiver in April 2022, with all surveyed districts utilizing the SSO waiver.

The nationwide waivers available at the onset of the COVID-19 pandemic were not widely available in the 2022–2023 school year. Instead, USDA issued operational waivers designed to help states and

districts respond to specific situations. Program operators were expected to use these waivers only when meal service was limited by the COVID-19 pandemic. Thus, in October 2022, 75 percent (68) of districts reported not using any waivers. Of those that were used, the Fiscal Action Flexibility for Meal Pattern Violations waiver, which allowed state agencies to forego financial corrective action for districts unable to meet the nutrition standards, was the most utilized.

Below is a list of the waivers, followed by a table that describes the extent to which they were used by the surveyed districts.

With rising food and labor costs, being reimbursed at the higher SFSP rate helped us break even. Additionally, reimbursing all students at the free rate eliminated meal debt, which is substantial in a large district such as ours."

Seamless Summer Option allowed schools to serve meals at no charge, while receiving the higher Summer Food Service Program reimbursement rate, instead of operating the School Breakfast Program and the National School Lunch Program under the normal rules for the regular school year. This waiver was only available during the 2021–2022 school year.


Meal Pattern and Fiscal

Challenges Faced by School Districts

With the loss of many federal waivers, along with ongoing pandemic-related issues in the 2022–2023 school year, districts continued to face a variety of operational challenges that decreased students' access to healthy

debt, supply chain disruptions, and labor shortages. Fortynine districts reported stagnant or decreased student enrollment from April 2022 to October 2022.

Of the 91 districts surveyed, 28 implemented the Community Eligibility Provision districtwide, and five additional districts were in states with Healthy School Meals for All policies. Fifty-eight districts returned to a tiered eligibility system in some capacity, meaning students qualified for either free, reduced-price, or paid meals. Forty of those districts utilized community eligibility, Provision 2, state legislation, or another non-pricing method to offer healthy school meals to all students in some schools, while 18 districts returned to a tiered eligibility system in all of their schools.

Sixty-three districts indicated challenges with school meal applications.3 Eighty-seven percent (55) of those districts reported difficulty getting families to complete applications, while 67 percent (42) struggled to get families to respond to verification requests. Additionally, 53 of the 58 (91 percent) districts that charged for meals during the 2022–2023 school year reported increased school meal debt.

Table C depicts the challenges districts reported for this school year.

Offering Free School Meals to All Students

State and local <u>Healthy School Meals for All</u> initiatives surged as states, school districts, families, and students refused to return to pre-pandemic operations. California and Maine created permanent Healthy School Meals for All policies, and Connecticut, Massachusetts, Nevada, and Vermont passed state legislation allowing districts to serve free meals to all students during the 2022–2023 school year.⁴ Eleven of the surveyed districts operated in states with Healthy School Meals for All policies. Twenty-two additional districts offered free meals to all students

through the districtwide implementation of the Community Eligibility Provision.

Districts that were able to continue offering school meals to all their students at no charge did not experience the decrease in school meals participation that the districts who returned to tiered eligibility systems experienced from April 2022 to October 2022.

Nearly every surveyed school district reported benefits to offering free meals to all students. Below is a table depicting those benefits.

Healthy School Meals for All Through State Legislation

In 2021, California and Maine became the first states to pass permanent Healthy School Meals for All policies. Vermont extended their Healthy School Meals for All policy through the 2022-2023 school year, and then passed a permanent policy effective in school year 2023-2024. Three additional states have extended free school meals through the 2022–2023 school year: Connecticut, Massachusetts, and Nevada.⁵ Over the last year, Colorado, Minnesota, and New Mexico have successfully enacted state policies that will start in school year 2023-2024.

Momentum for Healthy School Meals for All is growing. More than 20 additional states are working to adopt Healthy School Meals for All policies. The success of these state legislative efforts can be attributed to dedicated advocates and diverse coalitions. Students, parents and guardians, educators and education associations, anti-hunger and child advocates, and health organizations are working to ensure that all students have access to healthy school meals. Beyond State Legislation:

Options for Offering Healthy School Meals at No Charge

School districts surveyed are utilizing the following options to offer free meals to all students, with or without state legislation.

- **▶ Community Eligibility Provision:** CEP allows eligible schools to serve breakfast and lunch to all students at no charge, thus, reducing stigma and increasing participation in the programs. Community eligibility schools do not have to collect, process, or verify school meal applications, resulting in significant administrative savings for food and nutrition departments. - ▶ Provision 2: Schools using Provision 2 (a provision of the National School Lunch Act) do not need to collect, process, or verify school meal applications or keep track of meals by fee category for at least three out of every four years. Schools collect school meal applications and count and claim meals by fee category during
- year one of the multiyear cycle, called the "base vear." Those data then determine the federal reimbursement and are used for future years in the cycle. Provision 2 schools have the option to serve only breakfast or lunch, or both breakfast and lunch, to all students at no charge, and use economies of scale from increased participation and significant administrative savings. There is no eligibility requirement to participate in Provision 2; therefore, all school districts and/or schools could utilize this option to serve healthy meals to all students at no charge.
- ▶ Nonpricing: No fees are collected from students while schools continue to receive federal reimbursements for the meals served under the three-tier federal fee categories (free, reducedprice, and paid).6

How Community Eligibility Currently Works

Authorized by the Healthy, Hunger-Free Kids Act of 2010, community eligibility allows high-poverty schools to offer breakfast and lunch free of charge to all students, and to realize significant administrative savings by eliminating school meal applications. Any district, group of schools in a district, or school with 40 percent or more "identified students" — children who are eligible for free school meals who already are identified by means other than an individual household application — can choose to participate.7

"Identified students" include those who are in two categories:

- children who are directly certified for free school meals through data matching because their households receive Supplemental Nutrition Assistance Program, Temporary Assistance for Needy Families, or Food Distribution Program on Indian Reservations benefits, or, in some states, Medicaid benefits; and
- children who are certified for free meals without an application because they are homeless, migrant, enrolled in Head Start, or in foster care.

Community eligibility schools are reimbursed for meals served based on a formula. Reimbursements to the school are calculated by multiplying the identified student percentage (ISP) by 1.6 to determine the percentage of meals that will be reimbursed at the federal free rate. For example, a school with 50 percent identified students would be reimbursed at the free rate for 80 percent of the meals eaten (50 multiplied by 1.6 = 80), and at the paid rate for 20 percent.

Because the multiplier allows schools, groups of schools, and school districts with higher ISPs (60 percent or higher) to be reimbursed at the free rate for all or nearly all meals, the take-up rate for those schools is much higher than for eligible schools with a lower ISP. The current multiplier limits community eligibility from fully supporting high-poverty schools. Spotlight on Breakfast

Collectively, surveyed districts experienced a 5 percent decrease in average daily breakfast participation in October 2022 compared to April 2022, serving 100,747 fewer children each school day. Additionally, the ratio between students from households with low incomes participating in school breakfast compared to school lunch returned to prepandemic levels, with 56 students from households with low incomes participating in breakfast for every

100 that participated in lunch. With the return to normal operations, many of the barriers that kept students from participating in school breakfast before the pandemic, e.g., cost, stigma, and timing of breakfast service, may be reemerging. Implementing best practices, such as offering breakfast to all students at no charge and serving breakfast after the start of the school day, will ensure that students have the morning nutrition they need to learn, while

increasing the amount of federal reimbursement schools receive for serving breakfast.

Of the 91 surveyed districts, 18 reached FRAC's goal of serving school breakfast to 70 students from households with low incomes for every 100 participating in lunch.

Table E depicts the number of children from households with low incomes who participate in school breakfast for every 100 that participate in school lunch.



Pennsylvania Healthy School Breakfast for All: 2022–2023 School Year


At the beginning of the 2022–2023 school year, Pennsylvania provided funding to allow schools to offer breakfast to all students at no charge. As of March 2023, more than 23 million breakfasts were served to students through the program, and budget proposals recommended continued funding for Pennsylvania's Free School Breakfast Program.



A Proven Strategy to Increase Participation: Breakfast After the Bell

Incorporating breakfast into the school day overcomes common barriers to participation and supports students' access to this important morning meal. Combined with offering breakfast to all students at no charge, these innovative service models result in the highest level of school breakfast participation. There are three primary models schools use to serve breakfast after the bell:

- **Breakfast in the Classroom:**Meals are delivered to and eaten in the classroom at the start of the school day.
- "Grab and Go": Children (particularly older students) can quickly grab their breakfast from carts or kiosks in the hallway or the cafeteria line to eat in their classroom or in common areas.
- Second Chance Breakfast:
 Students are offered a second chance to eat breakfast after the school day starts. Many middle and high school students are not hungry first thing in the morning, but they are ready to eat breakfast after their first class of the day, helping them to focus on their classes until lunchtime.





Innovative Strategies and Partnerships

School nutrition departments employed a variety of creative strategies and unique partnerships to ensure students had access to healthy meals despite the challenges presented by losing federal waivers. Multiple districts garnered student input on new menu items, purchased local products, served meals from food trucks, hosted contests and incentives, and partnered with local businesses, agriculture producers, dairy associations, and higher education institutes to strengthen their programs.

"A new concept that we implemented this year was the use of QR codes and online surveys for our student taste tests ... This has really helped us learn which items our students like or dislike, as well as giving us a better understanding of how these items could be improved, so that we're able to share that information with manufacturers."

"We have four schools that utilize vending machines at lunch for reimbursable meals."

"We have worked to expand our menu offerings to students to be more inclusive of dietary and cultural needs. This includes offering more vegetarian options on the main menu each day, as well as beginning to offer more flavor profiles from the Asian, Latina and Italian cultures. For breakfast, we have worked to minimize the amount of prepackaged items and go to a more speed scratch or made in house sort of menu. We also continue to expand our fresh produce offerings and focus on bringing in locally sourced items."

"School Nutrition Services has implemented a Student Taste-Testing Initiative, which empowers students to provide valuable feedback on menu items. Following the collection of tallies, the selected student-preferred items will be incorporated into the menu, accompanied by the 'Student Voice, Student Choice' logo, thus recognizing and honoring their input."

"We have incorporated district chefs conducting live cooking demo stations one day a week at a high school. We have also acquired two food trucks used to visit schools to help improve excitement around lunchtime."

"[To increase participation] we are resurrecting and expanding second chance breakfast across high schools. [We are also] working with local nonprofits, elected representatives and [University of Wisconsin] to support student engagement/surveys, local procurement, culinary outreach events, and culinary development."

Policy Recommendations

To ensure children have access to healthy school meals, and districts have the support needed to operate viable programs, FRAC advocates for the following policy recommendations.

Make School Meals Available to All **Students at No Charge**

The federal waivers available during the COVID-19 pandemic served as a pilot for nationwide Healthy School Meals for All. Offering meals to all students at no cost provides the nutritional foundation that children need to grow, learn, and thrive. It also reduces stigma, supports academic achievement, and reduces families' household food costs. For districts, offering free school meals to all students supports program viability by increasing participation, streamlining operations, reducing administrative burden, and eliminating school meal debt.

Bold, permanent legislative action is needed to ensure that all students have access to healthy school meals at no charge. Federal legislation, such as the Universal Free School Meals Program Act of 2023, would help

ensure that every student in every state has access to school meals, as well as to the nutrition they need after school, during the summer, and at child care.

Community eligibility offers an important opportunity to increase the number of schools offering free meals to all students. Recently, USDA proposed a lower threshold for CEP eligibility, making approximately 20,000 more schools eligible to participate. While this proposed rule is an important step, most newly eligible schools and school districts will not be able to implement community eligibility without additional federal or state funding.

To fully leverage community eligibility as a tool to expand Healthy School Meals for All, Congress must increase the amount of federal funding community eligibility provides. The School Meals Expansion Act of 2023 (H.R. 2567) would increase the community eligibility multiplier from 1.6 to 2.5, which would increase the amount of federal funding a community eligibility school receives, and would lower the eligibility threshold to 25 percent, which is consistent with USDA's Proposed Rule. Furthermore, USDA can explore a statewide community eligibility option using its waiver or demonstration authority to support states' efforts to create Healthy School Meals for All policies.

Likewise, expanding direct certification would ensure that more eligible children automatically qualify for free school meals without an individual application. For example, Medicaid direct certification offers an important opportunity to certify children for both free and reduced-price school meals, and states that are not currently participating in the Medicaid Direct Certification Demonstration Pilots should apply when USDA issues the next Request for Proposals. Doing so would eliminate application barriers for eligible families, reduce administrative burden on districts, and support community eligibility.

Increase School Meal Reimbursements

Districts across the nation have reported challenges with rising food costs, supply chain disruptions, and labor shortages. Federal administrative and legislative action must support the financial viability of the school nutrition programs so that operators can continue serving students the most nutritious and appealing meals possible. The Healthy Meals Help Kids Learn Act of 2023 (H.R. 1269) would permanently increase the federal reimbursement rates for school breakfast by \$0.28 and school lunch by \$0.45, with a yearly adjustment for inflation.

Support Breakfast After the Bell Models

Making breakfast a part of the school day overcomes common school breakfast participation barriers and increases participation, helping to ensure that students can start the school day ready to learn. Local, state, and national initiatives that support breakfast after the bell models, such as additional school breakfast funding and supportive policies, will increase participation and ensure students have access to the nutrition needed. for academic achievement. Learn more about breakfast after the bell.





Technical Notes

From February 2023 to March 2023, FRAC distributed an electronic survey to 179 large public school districts nationwide. Ninety-one districts completed the survey, and the findings in this report are based on the information provided. For this report, a large district was defined as one with an enrollment greater than 7,000 students. The survey was composed primarily of multiplechoice questions and asked each school district about their breakfast and lunch participation and practices. The survey collected SBP, NSLP, and SSO data for April 2022: and SBP and NSLP data for October 2022. School districts were given an opportunity to review the tables included in this report and provide updated information prior to publication. The goals of this report include:

- ▶ Collect information on large district school nutrition operations during the 2021-2022 and 2022-2023 school years to understand the ongoing impact of the COVID-19 pandemic on operations and participation.
- ▶ Understand the extent to which the surveyed districts used the USDA's nationwide child nutrition waivers. and how the loss of those waivers affected school nutrition programs.
- ▶ Discover the extent to which the surveyed districts are implementing promising practices to maintain and increase participation, such as breakfast after the bell and offering meals at no charge to all students.
- Identify the benefits of offering school meals to all children at no charge as reported by the districts surveyed.

Participation in the school meals program was determined by self-reported numbers provided by each district as part of the survey. Due to rounding, totals in the tables may not precisely match.

Table 2: For school districts and schools that participate in the Community Eligibility Provision, the percentage of students certified for free and reduced-price school meals is based upon the free-claiming percentage (ISP multiplied by 1.6).

Table 4: To determine the average daily participation (ADP) in breakfast and lunch for April 2022 and October 2022, the total number of the meal type reported for each month was divided by the total number of serving days for each meal type and rounded to the nearest whole number for each district. Total ADP was calculated by adding together the ADP by meal type for each district. Inglewood Unified School District, Lynn Public Schools, Madison Metropolitan School District, Prince George's County Public Schools, St. Louis Public Schools, and Syracuse City School District did not report a separate number of operating days for lunch in either April 2022 or October 2022, so the number of operating days for breakfast was applied to the number of lunches served.

Table 7: Eleven districts, comprised of 1,676 schools. are in states with Healthy School Meals for All policies for the 2022—2023 school year. Of these, 168 schools are not utilizing the Community Eligibility Provision or Provision 2, but they are offering all students school meals at no charge.
